1 INTRODUCTION

This PIRMP is applicable across all Narrabri Coal Mine operations subject to Environment Protection Licence (EPL) 12789. The details of the EPL are outlined in Table 1.

2 NOTIFICATION AND COMMUNICATION REQUIREMENTS

2.1 Internal

Workers must notify their Supervisor who will then notify the General Manager, Environmental Manger or Surface Operations Manager of a pollution incident in accordance with Section 148 of the Protection of the Environment Operations Act 1997 (POEO Act).

In the event of an incident that requires an emergency response, the site's emergency management processes shall be implemented.

2.2 External

If the incident presents an immediate threat to the human health or property the site must contact 000 prior to any other action¹. Emergency services are the first responders and are responsible for controlling and containing incidents.

If the incident is determined to be notifiable under this Plan, and irrespective of whether emergency services have been contacted on 000, the General Manager, Surface Operations Manager or Environmental Manager (unless they have appointed a delegate) are the only positions authorised to contact the following authorities in the order listed (as required by the type and nature of the pollution event):

- 4. Local Government (Narrabri Shire Council) (02) 6799 6866
- 5. Fire and Rescue NSW 1300 729 579

The following information must be provided in accordance with Section 150 of the POEO Act:

- The time, date, nature, duration and location of the incident,
- The location of the place where pollution is occurring or is likely to occur,
- The nature, the estimated quantity or volume and the concentration of any pollutants involved, if known,
- The circumstances in which the incident occurred (including the cause of the incident, if known),
- The action taken or proposed to be taken to deal with the incident and any resulting pollution or threatened pollution, if known,
- Other information prescribed by the regulations.

In addition to the above agencies, notifications about the incident may also be required to be made outside of the requirements of this Plan. Additional notifications will be considered on a case by case basis and will generally be made to the regular Officer of the relevant Department.

2.3 <u>Community</u>

The site may partake in an awareness campaign, or campaigns, for relevant neighbours and community members prior to any incidents occurring so that those individuals are prepared in the event of an incident occurring.

Where there is a known possibility of an unavoidable incident precautions will be taken to provide prior warning to potentially affected landholders.

In the event of a notifiable pollution incident occurring, which impacts on neighbouring properties or the wider community, the affected landholder/s will be notified by the positions nominated above about the incident as soon as possible and informed as to any measures that could minimise the risk of harm as well as the control/containment and clean up mechanisms to be applied.

The type and frequency of follow up correspondence on the incident will be determined on a case by case basis.
