## 2. Overview of CCC Process

Danny Young, on behalf of the Whitehaven Group welcomed the the committee members to the first CCC meeting for the Rocglen Coal Mine. Reference was made to the Guidelines for Community Consultative Committees as produced by the Department of Planning and copies referred to the CCC members.

A brief discussion was held in relation to the role of the CCC, particularly in terms of providing a conduit between the Rocglen Coal Operation and the local community through the CCC membership.

Danny Young advised that the representation from Whitehaven Coal Mining at this meeting was more than will normally be the case, but it was felt important by the Company to introduce points of contact from Whitehaven to the CCC for any ongoing issues.

It was noted that Mr Rod Barnes and Mrs Jenny Meyers and her children also attended the meeting on advice that a community meeting was being held. Mr Barnes and Mrs Meyers were advised that the CCC process was a closed meeting to appointed CCC representatives and mine personnel only and that in future any issues they would like

raised at subsequent meetings should be referred through their community representatives. The process for being selected as a CCC member was explained and both parties advised that should they wish to seek appointment to the committee they would need to submit an expression of interest which would be forwarded to the Department of Planning for consideration. Following this advice, the committee agreed that Mr Barnes and Mrs Meyers could attend the meeting as visitors on this occasion.

### 3. Site Visit

The CCC members and visitors were escorted around the project site to provide an understanding as to the activities under way and the processes involved in coal mining. Specific points of reference on the site tour were:

- establishment of the workshop facilities area and ROM Pad
- Activities in pit and the removal of overburden
- the overburden emplacement area and haul route
- establishment of water management structures, seeding and groundcover establishment across areas of disturbance.

### 4. Mine Progress Report

Advice was presented to the CCC on the current status of mine development and expectation in relation to extraction of coal, completion of the haul route, overburden emplacement and rehabilitation requirements. The upgrade and deviation requirements and timing for Wean Road was also discussed at length.

## 5. Review of Environmental Performance

The CCC was presented with the range of approved Environmental management plans and requirements with regard to monitoring of environmental performance. A handout was presented to the CCC with monitoring results tabulated and graphed for their review.

In general terms, monitoring data is only preliminary at this stage, with ongoing collection of data as the mine progresses to provide information relative to any established trends over time. It was noted that noise monitoring had confirmed a minor exceedance in the early morning of 18<sup>th</sup> August and most likely associated with temperature inversion. Monitoring as the morning warmed confirmed noise compliance. With the warmer mornings, inversion impact has not been an ongoing issue at Rocglen, however this will be closely monitored over the winter period next year.

Rod Barnes raised issue that Jenny Meyers had some concerns over noise in that there was no monitoring identified on her property. Monitoring locations were explained, however it was advised that at the next event we would arrange for the consultant to take a reading at her property to obtain relevant information. Similarly, advised that we would also dip the bore on her property when doing the nominated monitoring bore nearby.

The CCC was advised that all monitoring results would be presented to the CCC at each meeting to encourage discussion and assessment of monitoring.

### 6. Complaints/Complaints Hotline

The committee was advised that a complaints hotline had been established and advertised in the local paper, and were informed of the hotline number: 0439441251.

Since the commencement of operations, two complaints have been recorded as follows:

## Complaint 1 – 12<sup>th</sup> August 2008

Trucks transporting demountable buildings to site overtook school bus on Wean Road which was unnecessary and dangerous. Complainant advised that the buildings were transported by a contract carrier for which we had little control over their conduct on a public road. The company in question was contacted and the complaint raised for their own internal investigations.

## Complaint 2 – 20<sup>th</sup> August 2008

Dust from Wean Road at the "Penryn" residence mainly due to mine related traffic. Mine traffic using this section of road was a temporary measure until the haul route was constructed. In order to address dust issue on the Wean Road, a water cart was contracted to adequately water down the road for dust suppression. Upon completion of the haul route it is expected that 90% of all mine related traffic will utilise the haul route.

### 7. General Business

Warren Nicholls raised concerns with regard to noise once haulage of coal commences on the haul route. Mr Nicholls was advised of the requirement for a road noise management plan and monitoring to confirm road noise levels. He was also advised of the make-up of the coal transport fleet, designed to minimise noise emissions. Mr Nicholls was advised to contact Rocglen if he finds noise levels from haulage to be of concern, upon which we would monitor noise levels at his residence.
